The cost is \$150.00 per team. No more than 4 persons per team. One stringer to be weighed per team consisting of 3 trout (Not more than 1 Trout over 25ö), and 1 Redfish (None over 28ö). The payout will be all entry fees less expenses. Payout will be as follows:

- 1st place team- 40%
- 2nd place team- 30%
- 3rd place team- 20%
- 4th place team- 10%

Contestants must be members of CCA. Memberships will be available the morning before fishing begins.

Boundaries are 124 High Island to San Luis Pass,

Tournament Rules

1. All anglers must weigh in at Stingaree Marina, 1297 N. Stingaree Rd, Crystal Beach, Texas 77650, 409-684-2731. 11am-2pm is weigh-in.
2. Fishing begins at 6:30. You may leave from wherever you choose.
3. Each angler must be a member of the CCA.
4. All persons in the boat must be entered in the Tournament.
5. Licensed Guides are not allowed to enter this tournament or be on the boats.
6. All fish must be caught by rod & reel in adherence to State Law only during tournament hours. No redfish over 28ö will be accepted.
7. Fishing hours are from 6:30 am to 2:00 pm on May 16st, 2015. Must be In line for Weigh-in by 2:00 pm at Stingaree Marina, 1297 N. Stingaree Rd, Crystal Beach. Teams must choose fish to bring to weigh in table. No additional fish will be weighed.
8. In case of a tie, the tie will be broken by the stringer that has the heaviest redfish. If still tied the stringer with the heaviest trout.
9. All decisions of the Tournament Director and the weigh master will be final.
10. Reschedule of the tournament will be the decision of the Tournament Director/Officials. If weather conditions do not permit a safe boating/ fishing day.

SIDE POT RULES

1. Side pots apply to individual entries and not part of the team entry fee. Entry into the side pot is not required to fish in the tournament.
2. All anglers on board must be registered contestants and follow all rules of the tournament. No local fishing guides allowed.
3. All anglers must have paid their öSide Potö fee by 6:30 am on 5/16/2015
4. Angler changes may be made only with prior approval of tournament Officials.
5. Illegal fish, by state law, will not be allowed. No redfish over 28öwill be accepted for weigh-in.
6. The largest fish in each category will be chosen by the angler and weighed in, one time, and marked by the weigh master.
7. The winner is determined by the heaviest total weight. In the event of a tie, the first fish weighed in wins.
8. In the event the tournament is rescheduled all side pots will be refunded.
9. All regular tournament rules apply.
